Please review the policies & statements below. You will be asked to confirm that you have read and agreed to the following before completing your registration. You may save or print this document for your own records.

Payment Policy: A \$100 non-refundable deposit is required to secure a spot PER student PER INTENSIVE/CAMP. No refunds will be given unless in case of injury, family emergency or if your spot can be taken by another student. Remaining balances are due <u>4 weeks before the camp/intensive start date</u>. Late payments will incur a \$20 late fee.

Refunds & Credits: Refunds and credits are not available for summer camps and intensives. The only exceptions would be in case of injury, illness or family emergency. If your child/teen is unable to attend for any reason please contact us immediately. Exceptions to this policy are made at the discretion of the Managing Director.

Release of Liability and Indemnification: As the legal parent or guardian, I release and hold harmless SADC, its employees and staff, and its Board of Directors from any and all liabilities, claims, demands, and causes of action, arising out of or relating to any personal injuries (including death) and property losses or damages that may be sustained by me or my child(ren) in connection with any activit(ies) occurring in or upon the premises of, or any premises under the control and supervision of, SADC. I further agree to indemnify SADC, its employees and staff, and its Board of Directors for any and all liabilities, claims, demands, and causes of action arising out of or relating to me or my child(ren)'s participation with any activit(ies) occurring in or upon the premises of, or any premises under the control and supervision of, SADC.

Use of Image: I am aware my child(ren) may be photographed and/or videotaped, in connection with the activities of SADC. My child(ren)'s name(s) will not be associated with such image(s). I hereby give my permission and consent for his/her image(s) to be included in any photographs, brochures, posters, flyers, videos, marketing materials, website content, and any other document. I release and hold harmless SADC from any and all damages, liabilities, and/or claims arising out of or relating to the usage of my child(ren)'s image(s) in any such materials.

Medical Emergency: As the legal parent or guardian, I give permission to SADC, its employees and staff, and its Board of Directors to seek medical treatment for my child(ren) in the event they are unable to reach me. I will provide SADC with telephone numbers where I can be contacted upon registration.

Attendance: Students must attend every day of the summer camp/intensive for which they have enrolled. Credits, refunds and prorated tuition are unavailable for missed classes.

Valuables: All students should be aware that there is no place to lock up valuables at the Center. Students should bring all valuables into class with them instead of leaving them unattended in the dressing rooms. This includes wallets, purses, computers, phones, jewelry, expensive/desirable clothing and shoes, etc.

Food & Drink: We ask that students come prepared each day with a healthy lunch, water, beverages and snacks each day for full day programs and healthy snacks, water and beverages for half day programs. Breaks and lunch periods are brief and students will not have time to leave the Center to purchase food.
